M4P builds upon the experience of the direct intervention approaches, which are limited in terms of outreach, efficiency, impact, and sustainability. M4P, therefore scores much higher in these aspects and is also relatively less expensive. ICCo brings in its experience and learning from its programs based on the M4P approach across the globe. The intent is also to develop and support programs based on this approach in India. With this objective, the training on M4P approach has been designed to introduce, develop understanding, and build expertise in the same. The training, though relevant for all fields, is designed keeping livelihoods as the base.
